Use clear and precise language. Avoid jargon or complex terminology that might be confusing to readers not familiar with the topic.

Proofread the paper for grammatical errors, spelling mistakes, and consistency in terminology.

*****EDITORIAL COMMENTS*****

Authors are advised to strictly incorporate the following points in the final paper:

1. The content matching must be within 20%. Single source matching not to exceed 4%.

2. All authors name, affiliation and mail ids must be there and the corresponding author to be marked. This is very important.

3. No biography or photos of authors should be there.

4. Authors must check the English language carefully.

5. Paper should be at least 10 pages in length on the Springer template. Beyond 12 pages, extra page charges apply.

6. The work must be original and should not have been submitted or published in any other conf or journal. At any point of time, if it is being traced that the paper/content is AI-generated then the paper will be rejected without refund of registration fee. Authors take their own responsibility to ensure that it is not AI generated.

7. Use uniform style for headings and subheading as per Springer template. Do not use IEEE Template.

8. The figures given in the papers should be 800dpi so that the picture clarity can be maintained.

9. All figures, equations and tables must be numbered properly and should be cited within the text.

10. Add missing publication details in references. All the references must be cited within the text.
